1 WHEREAS, the Papago Council did by Resolution No. 47-81, appropriate the 2 sum of \$17,500.00 of FY 1981 Federal Revenue Sharing Funds to 3 each of the eleven (11) Districts of the Papago Reservation to be expended by their respective District Councils in accordance 4 with the qualifying priorities expressed at the public hearings 5 6 conducted by the Papago Council for such purposes; and WHEREAS, the Hickiwan District Council has reviewed the requests of 7 District residents as expressed at such hearings and has allocated 8 the FY 1981 Federal Revenue Sharing Funds appropriated to it by 9 the Papago Council in accordance with the attached Resolution of 10 the District Council; and 11 WHEREAS, the Papago Council has reviewed the District Council's allocation 12 13 of such funds and approves thereof. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 14 approve of the allocation of Federal Revenue Sharing Funds 15 appropriated to the Hickiwan District pursuant to Papago Council 16 Resolution No. 47-81, in accordance with the attached District 17 Council Resolution, and does hereby authorize expenditure of 18 such funds in accordance therewith. 19 The foregoing Resolution was duly enacted by the Papago Council on the 20 day of November, 1981, at a meeting at which a quorum was present with a vote 1148.0 for; not voting; and 0 against; 0 21 pursuant to the authority vested in the Papago Council by Section 2 (a), (e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
