

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Approving Gu Vo District)
(Revenue Sharing FY'81 Budget)

RES. NO. 143-81

1 WHEREAS, the Papago Council did by Resolution No. 47-81, appropriate the
2 sum of \$17,500.00 of FY 1981 Federal Revenue Sharing Funds to
3 each of the eleven (11) Districts of the Papago Reservation to
4 be expended by their respective District Councils in accordance
5 with the qualifying priorities expressed at the public hearings
6 conducted by the Papago Council for such purposes; and

7 WHEREAS, the Gu Vo District Council has reviewed the requests of District
8 residents as expressed at such hearings and has allocated the
9 FY 1981 Federal Revenue Sharing Funds appropriated to it by
10 the Papago Council in accordance with the attached Resolution
11 of the District Council; and

12 WHEREAS, the Papago Council has reviewed the District Council's allocation
13 of such funds and approves thereof.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
15 approve of the allocation of Federal Revenue Sharing Funds
16 appropriated to the Gu Vo District pursuant to Papago Council
17 Resolution No. 47-81 in accordance with the attached District
18 Council Resolution.

19 The foregoing Resolution was duly enacted by the Papago Council on the 16th
20 day of November, 1981, at a meeting at which a quorum was present with a
21 vote of 1148.0 for; 0 against; 0 not voting; and 0 absent,
22 pursuant to the authority vested in the Papago Council by Section 2 (a) of
23 Article V of the Constitution and By-laws of the Papago Tribe of Arizona
24 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
25 by the Secretary of the Interior on January 6, 1937, pursuant to Section
26 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
27 subject to review by the Secretary of the Interior and is effective as of
28 the date of its enactment by the Papago Council.
