(Chart and Review Treasurers Job Description )



1 WHEREAS, in review of the administration's report of ANA's rejection of  
2 the Papago Tribe's CAP grant proposal questions of administrative  
3 procedures, accountability and responsibility were raised  
4 concerning the review and development of tribal grant proposals,  
5 as well as questions concerning the Tribe's long range social  
6 and economic development plans, which questions need review and  
7 resolution by the Papago Council.


8 NOW, THEREFORE, BE IT RESOLVED that the Papago Council wishes to review  
9 the job description of the Treasurer of the Papago Council, the  
10 tribal administrative plan, as well as any long range social  
11 and economic development plans of the Papago Tribe.

12 The foregoing Resolution was duly enacted by the Papago Council on the 5th  
13 day of November, 1981, at a meeting at which a quorum was present with a vote  
14 of 874.0 for; 0 against; 274.5 not voting; and 2 absent,  
15 pursuant to the authority vested in the Papago Council by Section 2 (e) and  
16 (f) of Article V of the Constitution and By-laws of the Papago Tribe of  
17 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
18 approved by the Secretary of the Interior on January 6, 1937, pursuant to  
19 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
20 not subject to review by the Secretary of the Interior and is effective as  
21 of the date of its enactment by the Papago Council.
