## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Special Appropriations Request - FY 1982)

RES. NO. 14-81

WHEREAS, the Papago Council has reviewed the social, economic and program 1 needs of the Papago Tribe; and 2 WHEREAS, the Papago Council has set certain priorities therefore for which 3 special FY 1982 funding and appropriations are urgently needed; and 4 WHEREAS, said social, economic and program needs of the Papago Tribe are of 5 direct concern and require the support and assistance, not only of 6 the Papago government, but of Federal agencies and the United States 7 Congress. 8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 9 establish the priorities set out in the attached Appropriation 10 Priority List and Continuing Appropriation Priority for Papago Farms. 11 BE IT FURTHER RESOLVED that the Chairman, Vice Chairman and other appropriate 12 officers, attorneys, departments and committees of the Papago Tribe 13 be and they are hereby authorized and directed to take any and all 14 steps necessary to seek the support and funds necessary to meet 15 said social, economic and program needs of the Papago Tribe, and 16 to coordinate their actions with all appropriate Federal agencies 17 in order to implement the purposes of this Resolution. 18 The foregoing Resolution was duly enacted by the Papago Council on the 19 day of February, 1981, at a meeting at which a quorum was present with a vote of 505.5 for; 455. against; 14.5 not voting; and 20 pursuant to the authority vested in the Papago Council by Section 2 (d) of 21 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of 22 the Act of June 18, 1934 (48 Stat. 984).
