1	WHEREAS,	the Sif Oidak District has within its IIM Account in excess of					
2		five hundred sixty-nine thousand, one hundred seventy-eight dollars					
3		and fifty cents (\$569,178.50), enough to allocate \$20,000.00 to					
4		each of its Communities in FY 1982; and					
5	WHEREAS,	the Sif Oidak District Council has allocated the sum of \$20,000.00					
6		of funds on deposit in the Sif Oidak District IIM Account to each					
7		of the following Communities to be expended by them during the 1982					
8		fiscal year in accordance with the budgets duly approved by their					
9		respective Community Councils, namely, to (1) Chui Chu Village;					
10		(2) Cockleburr Village; (3) Kohatk Village; (4) North Komelik					
11		Village; (5) Anegam Village; (6) Jointly to Jackrabbit and White					
12		Horse Pass Villages; and					
13	WHEREAS,	the Sif Oidak District is remote from Sells where Agency and Tribal					
14		Offices are located and it is very difficult for the District to					
15		manage its affairs and finances by means of IIM Accounts.					
16	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby						
17		approve the allocation of \$20,000.00 of funds on deposit in the					
18		Sif Oidak IIM Account to each of the aforementioned Communities to					
19		be expended by them during the 1982 fiscal year in accordance with					
20		budgets duly approved by their respective Community Councils.					
21	BE IT FURTHER RESOLVED that it does hereby authorize the Sif Oidak District						
22		Council to maintain separate District Checking and/or Savings					
23		Accounts with the First Interstate Bank of N.A. in Casa Grande,					
24		Arizona, which shall provide that any withdrawals from such accounts					
25		will require the signatures of two of the following officers of					
26		the District Council, i.e., the Chairman, Vice Chairman, Secretary					
27		or Clerk/Bookkeeper.					
28	BE IT FU	RTHER RESOLVED that the Sif Oidak District Council is authorized to					
29		transfer from the funds on deposit in the Districts IIM Account					
30		and into aforementioned accounts with the First Interstate Bank of					
31		Arizona, N.A., the sum of \$120,000.00, being the total amount of					
32		the Community budgets in the District.
