

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Setting Per Diem Fees for Members of Papago Council)

RES. NO. 15-81

1 WHEREAS, it is necessary to set per diem fees and cost reimbursements for
2 members of the Papago Council attending certain meetings of
3 committees of the Council and meetings designated by the Council.

4 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that representatives
5 to the Papago Council and their alternates shall be entitled to
6 receive, upon presentation of proper vouchers, the following
7 per diem and cost reimbursements:

8 1) Representatives and alternates designated to attend
9 special appropriation hearings in Washington, D. C.,
10 shall be entitled to standard tribal committee per
11 diem payments and mileage expenses for each day or
12 portion thereof they meet to prepare for the
13 appropriation hearings.


14 2) Representatives and alternates designated by the
15 Papago Council to represent the Papago Tribe at
16 meetings or functions outside of the Papago
17 Reservation shall be entitled to the standard
18 Council per diem for each day, or portion thereof,
19 they attend such meetings or functions, plus
20 standard tribal travel reimbursements.

21 The foregoing Resolution was duly enacted by the Papago Council on the 5th
22 day of February, 1981, at a meeting at which a quorum was present with a vote
23 of 464. for; 275.5 against; 225.5 not voting; and 2 absent,
24 pursuant to the authority vested in the Papago Council by Section 2 (e) and
25 (f) of Article V of the Constitution and By-laws of the Papago Tribe of
26 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
27 approved by the Secretary of the Interior on January 6, 1937, pursuant to
28 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
29 not subject to review by the Secretary of the Interior and is effective as
30 of the date of its enactment by the Papago Council.
