

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Rescinding Resolution No. 1136)

RES. NO. 161-81

1 WHEREAS, the Papago Council did by Resolution No. 1136, approve a
2 Resolution of the San Lucy (Gila Bend) District Council
3 authorizing deputies of the Sheriff of Maricopa County to
4 enter the Gila Bend Reservation to make arrests therein
5 pursuant to State law; and

6 WHEREAS, both of the foregoing Resolutions provide that the authority
7 granted thereunder can be withdrawn at any time; and

8 WHEREAS, the Law and Order Committee has determined that the Papago
9 Tribe, through its courts and police, can more properly
10 serve the law and order needs of the San Lucy District, and
11 has recommended rescission of the Resolution No. 1136.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does
13 hereby rescind Resolution No. 1136, and does hereby revoke
14 the authority of the office of the Sheriff of Maricopa County,
15 and its deputies, to enter upon the Gila Bend Reservation.

16 The foregoing Resolution was duly enacted by the Papago Council on the 22nd
17 day of December, 1981, at a meeting at which a quorum was present with a vote
18 of 1148.0 for; 0 against; 0 not voting; and 1 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (e) and
20 (f) and Section 3 (b) of Article V of the Constitution and By-laws of the
21 Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December
22 12, 1936, and approved by the Secretary of the Interior on January 6, 1937,
23 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
24 Resolution is effective as of the date of its approval by the Superintendent
25 of the Papago Agency and is subject to review by the Secretary of the Interior.
