## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Short/Long Range Plans - Social Programs)

RES. NO. 167-81

WHEREAS, the Papago Council on December 30, 1981, did pass the Liquor Ordinance, Ordinance No. 11-81; and WHEREAS, the Papago Council feels the need for the development of a short and long range plan due to the passage of the Ordinance. NOW, THEREFORE, BE IT RESOLVED that the Papago Council hereby directs the Chairman and the Directors of the Tribe's Social Programs (i.e., Children's Home, Children's Court, Adult Court, Alco-holism, Rehab Center) to draw up a short and long range plan concerning the effect of the passage of the Liquor Ordinance will have on the social problems of the Papago people. The foregoing Resolution was duly enacted by the Papago Council on the 30th

day of December, 1981, at a meeting at which a quorum was present with a vote of 1066.0 for; 0 against; 0 not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 2 (f), (h) and (m) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
