

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Adopting Fees for the Liquor Licenses)

RES. NO. 170-81

1 WHEREAS, the Papago Council did by Resolution No. 125-81, appoint
2 John B. Narcho, Harriet Toro and Andrew M. Patricio to be
3 the Liquor Commission; and

4 WHEREAS, the Liquor Commission have met and recommend to the Papago
5 Council the following fees to be considered in the Liquor
6 Ordinance, Article VI, Section 8, B and D, respectively:

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 agree to accept the fees recommended by the Liquor Commission.


14 BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the
15 Liquor Commission to work with the Tribe's Comptroller, Mr.
16 Reginald Henderson, in establishing the working capitol needed
17 to implement the purpose of the Liquor Ordinance.

18 The foregoing Resolution was duly enacted by the Papago Council on the 30th
19 day of December, 1981, at a meeting at which a quorum was present with a vote
20 of 1148.0 for; 0 against; 0 not voting; and 2 absent,
21 pursuant to the authority vested in the Papago Council by Section 2 (e) and
22 (f) of Article V of the Constitution and By-laws of the Papago Tribe of
23 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
24 approved by the Secretary of the Interior on January 6, 1937, pursuant to
25 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
26 not subject to review by the Secretary of the Interior and is effective as
27 of the date of its enactment by the Papago Council.
