16 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
 17 named applicants are eligible for enrollment as members of the
 18 Papago Tribe under Section 1 (a) or (b) of Article II of the
 19 Papago Constitution and By-laws, as amended, and their applications
 20 are approved, as herein above indicated.

21 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
 22 the Papago Tribe reduce this final determination in writing regarding
 23 each of the foregoing applications for enrollment in accordance with
 24 Section 3 (c) of Article III of the Papago Tribe Enrollment Ordinance;
 25 give notice of this Council's determination in accordance with Section
 26 4 of Article III of the Papago Tribe Enrollment Ordinance; and place
 27 the names of each applicant upon the Tribal Membership Roll in
 28 accordance with Article V of the Papago Tribe Enrollment Ordinance.

29 The foregoing Resolution was duly enacted by the Papago Council on the 3rd
 30 day of April, 1981, at a meeting at which a quorum was present with a vote of
 31 965 for; 0 against; 0 not voting; and 0 absent, pursuant to
 32 the authority vested in the Papago Council by Article II and Article V, Section
 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
 ratified by the Papago Tribe on December 12, 1936, and approved by the
