

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Gu Vo District Revenue Sharing Budget)

RES. NO. 42-81


1 WHEREAS, the Papago Council did by Resolution 11-80 allocate \$10,571.85
2 of Federal Revenue Sharing funds to the Gu Vo District to be
3 expended by the District Council in accordance with the
4 qualifying priorities expressed at the Public Revenue Sharing
5 hearings; and

6 WHEREAS, the Gu Vo District Council has reviewed such priorities and
7 has adopted the attached Revenue Sharing Budget (General Repairs
8 of Gu Vo District Building) in the sum of \$10,571.85, subject to
9 the approval of the Papago Council.


10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the attached
11 Revenue Sharing Budget of the Gu Vo District is hereby approved.

12 The foregoing Resolution was duly enacted by the Papago Council on the 3rd
13 day of April, 1981, at a meeting at which a quorum was present with a vote of
14 857.5 for; 0 against; 0 not voting; and 4 absent, pursuant to
15 the authority vested in the Papago Council by Section 2 (e), (f) and (h) of
16 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
20 review by the Secretary of the Interior and is effective as of the date of
21 its enactment by the Papago Council.
