

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Directing Advertisement of the Position)
(of Judge of Children's Court)



1 WHEREAS, the term of office of Ned Norris, Jr., as Judge of the Children's
2 Court has expired and the Law and Order Committee has, at the
3 suggestion of Judge Norris, recommended that the position be
4 advertised in accordance with the provisions of the Personnel
5 Policies.

6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Personnel
7 Officer advertise the position of Judge of the Children's Court
8 in accordance with the provisions of the Personnel Policies.

9 The foregoing Resolution was duly enacted by the Papago Council on the 8th
day of May, 1981, at a meeting at which a quorum was present with a vote of
10 911.5 for; 0 against; 53.5 not voting; and 0 absent, pursuant
11 to the authority vested in the Papago Council by Section 2 (e) and (f) of
Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
12 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
13 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of
its enactment by the Papago Council.
