Mark Lopez BE IT FURTHER RESOLVED that the Rodeo Committee shall receive the part time services of a Secretary to be assigned to it by Tribal Administration, 15 and that the Committee account to the Treasurer of the Papago 16 Council for its receipts and disbursements in accordance with 17 18 procedures to be established by the Treasurer. The foregoing Resolution was duly enacted by the Papago Council on the 8th 19 day of May, 1981, at a meeting at which a quorum was present with a vote of against; 0 not voting; and for; 20 l absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as 21 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
