

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Reviewed Request for Personnel Committee Budget)

RES. NO. 53-81

WHEREAS, the Papago Council did on February 12, 1980, appoint a Personnel Committee in accordance with the provisions of the Personnel Policies and Procedures of the Papago Tribe; and

WHEREAS, the Papago Council did not establish and approve a budget for the Personnel Committee and the Committee has submitted a request for such budget in the sum of \$16,200.00 to cover the per diem and mileage costs of its members; and

WHEREAS, the Papago Council has considered such request, the fact that the Papago Tribe is presently short of funds, and the fact that members of the Committee are in tribal employment.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the request of the Personnel Committee for a Committee budget is tabled.

The foregoing Resolution was duly enacted by the Papago Council on the 8th day of May, 1981, at a meeting at which a quorum was present with a vote of 697.0 for; 64.5 against; 165.5 not voting; and 1 absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
