

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving San Lucy District Revenue Sharing Budget)

RES. NO. 57-81

1 WHEREAS, the Papago Council did by Resolution No. 47-81 allocate \$17,500.
2 of FY 1981 Federal Revenue Sharing funds to each of the eleven
3 (11) Districts of the Papago Reservation to fund qualified
4 District projects and programs under budgets adopted by their
5 respective District Councils and approved by the Papago
6 Council; and

7 WHEREAS, the San Lucy District Council did by Resolution No. 5-81 dated
8 April 24, 1981, approve a Revenue Sharing budget in the sum
9 of \$17,500; and

10 WHEREAS, said budget appears to meet the qualifying priorities of the
11 San Lucy District as expressed at the public hearings conducted
12 by the Papago Council.

13 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
14 approve the attached FY 1981 Revenue Sharing budget of the
15 San Lucy District in the sum of \$17,500.

16 The foregoing Resolution was duly enacted by the Papago Council on the 2nd
17 day of June, 1981, at a meeting at which a quorum was present with a vote of
18 1148.0 for; 0 against; 0 not voting; and 0 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (f) and
20 Section 3 (a) of Article V of the Constitution and By-laws of the Papago
21 Tribe of Arizona as amended, ratified by the Papago Tribe on December 12,
1936, and approved by the Secretary of the Interior on January 6, 1937,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
Resolution is effective as of the date of its approval by the Superintendent
of the Papago Agency and is subject to review by the Secretary of the
Interior.
