

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Approving Sif Oidak District Budget)

RES. NO. 62-81

1 WHEREAS, the Papago Council did by Ordinance No. 03-80, appropriate from  
2 the funds in the District IIM Accounts the sum of \$219,695.00  
3 (representing rental income derived from mining activities  
4 carried on within the Sif Oidak District) and the sum of \$375,594.24  
5 (representing earned mining income) for the benefit of the Sif  
6 Oidak District, to be expended by the District under budgets or  
7 Resolutions of its Council duly approved by the Papago Council;  
8 and

9 WHEREAS, the Sif Oidak District Council has by Resolution dated May 27,  
10 1981, approved and adopted a budget for the Sif Oidak District  
11 Summer Recreation Program in the sum of \$4,575.80, which program  
12 will serve 200 young people of the District for a six (6) week  
13 period between June 16 and July 24, 1981; and

14 WHEREAS, the Papago Council supports the Sif Oidak District Summer  
15 Recreation Program.

16 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
17 approve the attached budget in the sum of \$4,575.80 for the Sif  
18 Oidak District Summer Recreation Program and authorizes the  
19 expenditure thereof from funds appropriated to the Sif Oidak  
20 District under Ordinance No. 03-80.

21 The foregoing Resolution was duly enacted by the Papago Council on the 2nd  
22 day of June, 1981, at a meeting at which a quorum was present with a vote of  
23 1148.0 for; 0 against; 0 not voting; and 2 absent, pursuant  
24 to the authority vested in the Papago Council by Section 2 (f) and Section 3  
25 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
26 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
27 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
28 Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the  
29 date of its approval by the Superintendent of the Papago Agency and is subject  
30 to review by the Secretary of the Interior.
