WHEREAS, the Papago Council did by Ordinance No. 03-80, appropriate from 1 the funds in the District IIM Accounts the sum of \$219,695.00 2 (representing rental income derived from mining activities 3 carried on within the Sif Oidak District) and the sum of \$375,594.24 4 (representing earned mining income) for the benefit of the Sif 5 6 Oidak District, to be expended by the District under budgets or Resolutions of its Council duly approved by the Papago Council; 7 and 8 WHEREAS, the Sif Oidak District Council has by Resolution dated May 27, 9 1981, approved and adopted a budget for the Sif Oidak District 10 Summer Recreation Program in the sum of \$4,575.80, which program 11 will serve 200 young people of the District for a six (6) week 12 13 period between June 16 and July 24, 1981; and WHEREAS, the Papago Council supports the Sif Oidak District Summer 14 Recreation Program. 15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 16 approve the attached budget in the sum of \$4,575.80 for the Sif 17 Oidak District Summer Recreation Program and authorizes the 18 expenditure thereof from funds appropriated to the Sif Oidak 19 District under Ordinance No. 03-80. 20 The foregoing Resolution was duly enacted by the Papago Council on the 2nd 21 day of June, 1981, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 against; 0 not voting; and 2 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and Section 3 absent, pursuant 22 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona 23 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
