12	Rosita Ruiz, respectively the Chairman, Vice Chairman and
13	Treasurer of the Papago Council, are hereby authorized to
14	negotiate and execute the contract and any amendments thereto
15	on behalf of the Papago Tribe.
16 17	The foregoing Resolution was duly enacted by the Papago Council on the 17th day of June, 1981, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 against; 0 not voting; and absent, pursuant to
18	the authority vested in the Papago Council by Section 2 (a) and (d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
19	amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
20	the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of
21	its enactment by the Papago Council.
