

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(ENROLLMENT - JULY)

RES. NO. 73-81

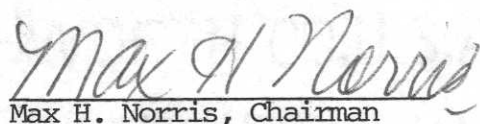

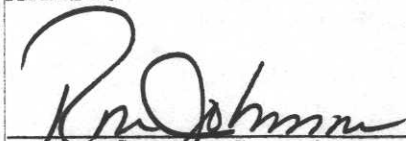
1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the
2 above named applicants are eligible for enrollment as members
3 of the Papago Tribe under Section 1 (a) or (b) of Article II
4 of the Papago Constitution and By-laws, as amended, and their
5 applications are approved, as herein above indicated.
6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers
7 of the Papago Tribe reduce this final determination in writing
8 regarding each of the foregoing applications for enrollment in
9 accordance with Section 3 (c) of Article III of the Papago Tribe
10 Enrollment Ordinance; give notice of this Councils determination
11 in accordance with Section 4 of Article III of the Papago Tribe
12 Enrollment Ordinance; and place the names of each applicant upon
13 the Tribal Membership Roll in accordance with Article V of the
14 Papago Tribe Enrollment Ordinance.

15 The foregoing Resolution was duly enacted by the Papago Council on the 10th
16 day of July, 1981, at a meeting at which a quorum was present with a vote of
17 1148.0 for; 0 against; 0 not voting; and 0 absent, pursuant
18 to the authority vested in the Papago Council by Article II and Article V,
19 Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona
as amended, ratified by the Papago Tribe on December 12, 1936, and approved
by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
to review by the Secretary of the Interior and is effective as of the date
of its enactment by the Papago Council.
