

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Approving Schuk Toak District Budget)

RES. NO. 78-81

1 WHEREAS, the Schuk Toak District Council did, by Resolution dated July 7,  
2 1981, approve and adopt a budget of \$28,500.00 for a Summer Youth  
3 Employment Program to be funded with funds appropriated to the  
4 Schuk Toak District from the District IIM Accounts under the  
5 provisions of Ordinance No. 3-80; and

6 WHEREAS, the Papago Council does approve of the attached budget for the  
7 Summer Youth Employment Program of the Schuk Toak District.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
9 approve the attached budget in the sum of \$28,500.00 for the  
10 Summer Youth Employment Program of the Schuk Toak District,  
11 and authorizes the expenditures of funds appropriated by the  
12 Papago Council to the GuVo District under Ordinance No. 3-80  
13 in accordance with the provisions of the Resolution of the  
14 Schuk Toak District Council dated July 7, 1981.

15 The foregoing Resolution was duly enacted by the Papago Council on the 13th  
16 day of July, 1981 at a meeting at which a quorum was present with a vote  
17 of 1094.0 for; 0 against; 0 not voting; and 3 absent,  
18 pursuant to the authority vested in the Papago Council by Section 3 (a) of  
19 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
20 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
21 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
22 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of  
23 the date of its approval by the Superintendent of the Papago Agency and is  
24 subject to review by the Secretary of the Interior.
