## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Approving Schuk Toak District Budget)

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 8 9 approve the attached budget in the sum of \$28,500.00 for the Summer Youth Employment Program of the Schuk Toak District, 10 11 and authorizes the expenditures of funds appropriated by the 12 Papago Council to the GuVo District under Ordinance No. 3-80 13 in accordance with the provisions of the Resolution of the Schuk Toak District Council dated July 7, 1981. 14 The foregoing Resolution was duly enacted by the Papago Council on the 13th day of July , 1981 at a meeting at which a quorum was present with a vote of 1094.0 for; 0 against; 0 not voting; and 3 absent, 16 pursuant to the authority vested in the Papago Council by Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as 17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by 18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
