

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Schuk Toak District Building)

RES. NO. 79-81

1 WHEREAS, the Schuk Toak District Council did, by Resolution dated June 23,
2 1981, inform the Papago Council of their need of a District
3 building; and
4 WHEREAS, the Papago Council does approve of the attached resolution expend-
5 ing \$130,000.00 from the Schuk Toak District IIM Account, allocated
6 under the provisions of Ordinance 03-80; and
7 WHEREAS, the Papago Council did by Resolution 47-81 did allocate \$17,500.00
8 of Federal Revenue Sharing funds to the Schuk Toak District to be
9 expended in accordance with priorities expressed at the Revenue
10 Sharing Public Hearings; and
11 WHEREAS, the Schuk Toak District Council has reviewed such priorities and
12 has adopted the attached Resolution expending Revenue Sharing
13 funds (match funds for District Building) in the sum of \$17,500.00
14 subject to the approval of the Papago Council.
15 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve
16 the attached Resolution of the Schuk Toak District Council
17 expending the aggregate sum of \$147,500.00.
18 The foregoing Resolution was duly enacted by the Papago Council on the 13th
19 day of July, 1981, at a meeting at which a quorum was present with a vote of
20 1094.0 for; 0 against; 0 not voting; and 3 absent, pursuant to
21 the authority vested in the Papago Council by Section 3 (a) of the Constitution
22 and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago
23 Tribe on December 12, 1936, and approved by the Secretary of the Interior on
24 January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
25 984). Said Resolution is effective as of the date of its approval by the
26 Superintendent of the Papago Agency and is subject to review by the Secretary
27 of the Interior.
