


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving FY '82 Sif Oidak District Budget)


1 WHEREAS, the Sif Oidak District Council did, by Resolution
2 dated July 9, 1981, did approve and adopt a budget
3 for FY 1982 in the amount of \$68,545.00 to be funded
4 by appropriations from the Sif Oidak District IIM
5 Account under the provisions of Ordinance 03-80; and
6 WHEREAS, the Papago Council does approve of attached budget
7 for the Sif Oidak District.
8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it
9 does hereby approve the attached budget in the sum
10 of \$68,545.00 for the Sif Oidak District FY 1982
11 budget and authorizes the expenditure of funds
12 appropriated by the Papago Council to the Sif Oidak
13 District under Ordinance 03-80 in accordance with the
14 provisions of the Resolution of the Sif Oidak District
15 Council dated July 9, 1981.

16 The foregoing Resolution was duly enacted by the Papago Council
17 on the 13th day of July, 1981 at a meeting at which a
18 quorum was present with a vote of 1055.5 for; 0 against;
19 142.5 not voting; and 3 absent, pursuant to the authority
20 vested in the Papago Council by Section 3 (a) of Article V of the
21 Constitution and by-laws of the Papago Tribe Arizona as amended,
22 ratified by the Papago Tribe on December 12, 1936, and approved
23 by the Secretary of the Interior on January 6, 1937, pursuant to
24 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
25 Resolution is effective as of the date of its approval by the
26 Superintendent of the Papago Agency and is subject to review by
27 the Secretary of the Interior
