

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving FY '82 Gu Achi District Budget)

RES. NO. 84-81

1 WHEREAS, the Gu Achi District Council did by Resolution adopt the attached
2 FY 1982 budget, in the amount of \$124,713.00, for the Gu Achi
3 District; and
4 WHEREAS, the Papago Council has reviewed said budget and has determined
5 that the Gu Achi District has sufficient funds available to fund
6 its FY 1982 budget; and
7 WHEREAS, the Papago Council did by Resolution 47-81 allocated \$17,500.00
8 of Federal Revenue Sharing funds to the Gu Achi District to be
9 expended by the District Council in accordance with the qualifying
10 priorities expressed at the Revenue Sharing Public Hearings; and
11 WHEREAS, The Gu Achi District Council has reviewed such priorities and
12 has adopted the attached Revenue Sharing Budget (rehabilitation
13 of homes for the Elderlys, Handicapped, and the very needy
14 families) in the sum of \$17,500.00, subject to the approval of the
15 Papago Council.
16 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve
17 the attached Revenue Sharing Budget of the Gu Achi District
18 Council;
19 BE IT FURTHER RESOLVED by the Papago Council that it does hereby approve
20 the attached FY 1982 budget of the Gu Achi District in the
21 aggregate sum of \$142,213.00.

22 The foregoing Resolution was duly enacted by the Papago Council on the 13th
23 day of July, 1981 at a meeting at which a quorum was present with a
24 vote of 1094.0 for; 0 against; 0 not voting; and 3 absent,
25 pursuant to the authority vested in the Papago Council by Section 3 (a) of
26 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
27 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
the date of its approval by the Superintendent of the Papago Agency and is
subject to review by the Secretary of the Interior.


