

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Consent to Grants of Rights-of-Way to)
(APS at Florence Village)

RES. NO. 85-81

1 WHEREAS, the residents of Papago-Florence Village are desirous of getting
2 electricity to their homes; and

3 WHEREAS, the Arizona Public Service Company ("APS") has an existing
4 electrical line right-of-way across a portion of said Village,
5 and is interested in extending its service to serve residents of
6 the Village on condition that it can obtain necessary easements
7 for periods of fifty years with waivers of compensation and the
8 rights to construct, operate, repair and remove improvements
9 placed thereon, and to transfer its interest in the easement by
10 assignment, grant, or otherwise; and

11 WHEREAS, the Gu Achi District Council has approved the application of APS
12 and has recommended that a waiver of compensation be granted since
13 the benefit of the electrical services to the Village residents
14 will more than offset any monetary consideration; and

15 WHEREAS, the Papago Tribal Utility Authority has determined that Florence
16 Village is not within its service area, and that APS' stated
17 conditions of service are standard in the trade.

18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
19 consent to grants of easement to Arizona Public Service Company,
20 its successors and assigns, for rights-of-way for the construction,
21 operation, repair, maintenance, replacement and removal of electric
22 service lines and improvements on, over, across, in and upon the
23 lands of Papago-Florence Village for service to, and requested by,
24 residents of the Village.

25 BE IT FURTHER RESOLVED that such easements be for periods of fifty years;
26 that compensation for grants thereof be waived; and that such
27 easements, and any interest therein, be subject to transfer by
28 assignment, grant, or otherwise.

29 BE IT FURTHER RESOLVED that the foregoing consent to grants of easement to
30 service residents of Papago-Florence Village shall be a continuing
31 one and shall be in full force and effect until revoked by the
32 Papago Council.

1 The foregoing Resolution was duly enacted by the Papago Council on the 13th
2 day of July, 1981, at a meeting at which a quorum was present with a
3 vote of 1094.0 for; 0 against; 0 not voting; and 3 absent,
4 pursuant to the authority vested in the Council by Section 2 (a) and (c) of
5 Article V of the Constitution and By-laws of the Papago Tribe as amended,
6 ratified by the Papago Tribe on December 12, 1936, and approved by the
7 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the
8 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
9 review by the Secretary of Interior and is effective as of the date of its
10 enactment by the Papago Council.
