

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Approving Chukut Kuk Districts Revenue Sharing Budget)

RES. NO. 89-81

1 WHEREAS, the Papago Council did by Resolution No. 47-81 appropriate the sum  
2 of \$17,500.00 of Fy 1981 Federal Revenue Sharing Funds to each of  
3 the eleven (11) Districts of the Papago Reservation to be expended  
4 by their respective District Councils in accordance with the  
5 qualifying priorities expressed at the public hearings conducted  
6 by the Papago Council for such purpose; and


7 WHEREAS, the Chukut Kuk District Council did meet on July 18, 1981, and  
8 recommended the expenditure of \$3,127.00 of the funds allocated to  
9 the District to rehabilitate the home of Matilda Salvicio; and

10 WHEREAS, the Papago Council has reviewed the Districts recommendations and  
11 approved of same.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
13 approve of the allocation by the Chukut Kuk District Council of  
14 the sum of \$3,127.00 of Federal Revenue Sharing funds appropriated  
15 to the Chukut Kuk District pursuant to Papago Council Resolution  
16 No. 47-81, and does hereby authorize expenditure of such funds in  
17 accordance with the attached Resolution of the Chukut Kuk District  
18 Council.


19 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
20 day of August, 1981, at a meeting at which a quorum was present with a vote of  
21 1148.0 for; 0 against; 0 not voting; and 1 absent, pursuant  
22 to the authority vested in the Papago Council by Section 3(a) of Article V of  
23 the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified  
24 by the Papago Tribe on December 12, 1936, and approved by the Secretary of the  
25 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934  
26 (48 Stat. 984). Said Resolution is effective as of the date of its approval  
27 by the Superintendent of the Papago Agency and is subject to review by the  
28 Secretary of the Interior.
