Francisco, Jr., Vice Chairman or Ms. Rosita Ruiz, 5 Treasurer, is hereby authorized to negotiate and execute these 6 contracts and any amendments thereto for the duration of the 7 contracts. 8 The foregoing Resolution was duly enacted by the Papago Council on the 10th day of August, 1981, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 9 against; 0 not voting; and 1 absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of 10 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by 11 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
