6	WHEREAS,	the Community of Sells, with a rapidly growing population and a						
7		combined Tribal Government - B.I.A I.H.S. annual payroll exceeding						
8		\$11,000,000.00 needs a regular banking facility including safe						
9		deposit box services; and						
10	WHEREAS,	space has been set aside for a modern banking facility in the new						
11		EDA - approved Sells Shopping Center and lease/design negotiations						
12		with Valley National Bank officials have already started; and						
13	WHEREAS,	Valley National Bank officials must now proceed with their applica-						
14		tion process for obtaining Arizona State regulatory and bank board						
15		approval for opening a Sells branch bank and first need Papago						
16		Tribal Council approval.						
17	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby							
18		approve Valley National Bank of Arizona as the bank of choice to						
19		open and operate a branch banking facility at Sells, Arizona.

21		actions necessary to assist the Valley National Bank in success-						
22		fully locating a branch bank at Sells, Arizona.
