

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Approving Amendment of Pisinemo District's 1983 Budget

RES. NO. 02-83

1 WHEREAS, the Pisinemo District Council did on December 28, 1982, by Resolution
2 No. 03-82, a copy of which is attached hereto, approve an amendment
3 of the District's 1983 budget and authorize the expenditure of
4 District funds to cover the cost of purchasing a van and insurance;
5 and

6 WHEREAS, the Papago Council has reviewed the proposed amendment of the
7 District's 1983 budget and has determined that the District has
8 sufficient funds to cover the proposed expenditures.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 approve the amendment of the Pisinemo District's 1983 budget as
11 provided in the attached Resolution of the Pisinemo District
12 Council and does hereby authorize expenditure of District funds
13 in accordance therewith.

14 The foregoing Resolution was duly enacted by the Papago Council on the 6th
15 day of January, 1983, at a meeting at which a quorum was present with a vote
16 of 1148.0 for; 0 against; 0 not voting; and 4 absent,
17 pursuant to the authority vested in the Papago Council by Section 3 (a) of
18 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
19 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
the date of its approval by the Superintendent of the Papago Agency and is
subject to review by the Secretary of the Interior.
