

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Approving FY 1983 Community Budgets of Hickiwan District

RES. NO. 03-83

1 WHEREAS, the Hickiwan District Council did on December 20, 1982, by
2 Resolution No. 08-82, a copy of which is attached hereto, appro-
3 priate \$5,000.00 for each of the seven villages of the Hickiwan
4 District in accordance with the individual budgets of such
5 villages from District funds; and

6 WHEREAS, the Papago Council has reviewed the proposed village budgets and
7 has determined that the District has sufficient funds to cover
8 the proposed expenditures.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 approve the village budgets of the Hickiwan District or an amend-
11 ment to the District's 1983 budget and does hereby authorize
12 expenditure of District funds in accordance therewith.

13 The foregoing Resolution was duly enacted by the Papago Council on the 6th
14 day of January, 1983, at a meeting at which a quorum was present with a vote
15 of 1148.0 for; 0 against; 0 not voting; and 4 absent,
16 pursuant to the authority vested in the Papago Council by Section 3 (a) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
19 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
20 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
21 the date of its approval by the Superintendent of the Papago Agency and is
22 subject to review by the Secretary of the Interior.
