

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Approving Amended 1983 Budget of San Lucy District

RES. NO. 04-83

1 WHEREAS, the San Lucy District Council did on January 04, 1983, by Resolution
2 No. 14-83, a copy of which is attached hereto, adopt an amended
3 District budget covering the period from January 01, 1983, through
4 September 30, 1983, and has requested authority to transfer
5 \$34,789.24 from the District's IIM account to the District's account
6 with the Valley National Bank in Gila Bend; and

7 WHEREAS, the Papago Council has reviewed and approved such budget and
8 request.

9 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve the
10 attached amended budget of the San Lucy District Council for the
11 period of January 01, 1983, through September 30, 1983, does hereby
12 authorize the transfer of \$34,789.24 from the San Lucy District's
13 IIM account to the District's account (Account No. 2186-1432) with
14 the Valley National Bank in Gila Bend, and does hereby authorize
15 expenditure of such funds in accordance with such budget.

16 The foregoing Resolution was duly enacted by the Papago Council on the 6th
17 day of January, 1983, at a meeting at which a quorum was present with a vote
18 of 1148.0 for; 0 against; 0 not voting; and 3 absent, pursuant
19 to the authority vested in the Papago Council by Section 3 (a) of Article V
20 of the Constitution and By-Laws of the Papago Tribe of Arizona as amended,
21 ratified by the Papago Tribe on December 12, 1936, and approved by the
22 Secretary of the Interior on January 06, 1937, pursuant to Section 16 of the
23 Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the
24 date of its approval by the Superintendent of the Papago Agency and is subject
25 to review by the Secretary of the Interior.
