

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Requesting Transfer of B.I.A. Buildings

RES. NO. 08-83

1 WHEREAS, the Bureau of Indian Affairs has offered to transfer several
2 buildings located at old Santa Rosa and Sells which have been
3 declared surplus to the needs of the Papago Agency; and
4 WHEREAS, the Papago Council has considered the offer and has determined
5 that it would be in the best interest of the Papago Tribe and
6 the Gu Achi District to receive such buildings and related
7 personal property; and
8 WHEREAS, the Papago Council did on October 4, 1982, by Resolution No.
9 143-82, request the B.I.A. to transfer buildings 409, of cement
10 block construction, located at old Santa Rosa and consisting of
11 approximately 2,798 sq. ft. and building 58, of adobe construction,
12 located in Sells and consisting of approximately 910 sq. ft.; and
13 WHEREAS, there was a mistake in this request in that the intent was to
14 request the B.I.A. to transfer all the available surplus buildings
15 to the Papago Tribe.
16 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby amend
17 Resolution No. 143-82, and adds the following buildings to the
18 request to transfer, including 409 and 58;
19 Located in Section 2, T. 13S., R 3E, G & SRB & M Arizona unsurveyed.
20 Bldg. 408 Pumphouse, 206 sq. ft. wood frame stucco exterior,
21 Bldg. 409 Qtrs. Multiple, 2798 sq. ft. cement block construction,
22 Bldg. 410 other buildings (old kitchen) 2088 sq. ft. cement block const.
23 Bldg. 411 Qtrs. Multiple, 6726 sq. ft. cement block construction,
24 Bldg. 414 Quarters, 983 sq. ft. wood frame construction,
25 Bldg. 415 Quarters, 983 sq. ft. wood frame construction,
26 Bldg. 416 Garage, 584 sq. ft. wood frame stucco exterior.
27 1011 LP Gas District lines, 1100 lin. ft.,
28 1023 LP Gas storage tanks, 2 each (2752 gal.cap.),
29 1605 water pump & well, 1 each, 10 HP, 50 GPM,
30 1609 water storage tank, 25,000 gal. cap.,
31 1626 water Dist. lines, 1450 lin. ft.,
32 1921 sewage disp. lines, 1550 lin. ft.

The foregoing Resolution was duly enacted by the Papago Council on the 6th
day of January, 1983, at a meeting at which a quorum was present with a vote
of 1148.0 for; 0 against; 0 not voting; and 3 absent,
pursuant to the authority vested in the Papago Council by Section 2 (a) and
Section 3 (h) of Article V of the Constitution and By-laws of the Papago Tribe
of Arizona as amended, ratified by the Papago Tribe on December 23, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
subject to review by the Secretary of the Interior and is effective as of the
date of its enactment by the Papago Council.
