	WHEREAS, the Papago Tribe wishes to provide Human Services to its members						
4	by creating a Social Service Program that will be a accessible to						
5	all people and will provide quality services; and						
6	WHEREAS, the Social Services Program is currently being administered by the						
	Bureau of Indian Affairs, Social Services Branch; and						
7	WHEREAS, the intent of P. L. 93-638 Self-Determination and Education						
8	Assistance Act is to encourage Tribes to assume more and more						
9	responsibility over their programs; and						
	WHEREAS, the Papago Tribe believes it is in a better position to provide for						
10	the welfare of its members by developing a Social Services Program						
11	which will identify and address their particular needs.						
12	NOW, THEREFORE, BE IT RESOLVED that the Papago Tribe, pursuant to the provisions of the Indian Self-Determination and Education Assistance Act						
13	of 1975, P. L. 93-638, intends to contract with the Bureau of Indian						
	Affairs for the transfer of all Social Service functions currently						
14	being administered by the Bureau of Indian Affairs.						
15	BE IT FURTHER RESOLVED that the duration of this contract shall be from						
16	October 1, 1983, through September 30, 1984.						
17	BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice						
	Chairman, or Rosita N. Ruiz, Treasurer, of the Papago Council are						
18	hereby authorized to negotiate and execute the contract and any						
19	amendments thereto on behalf of the Papago Tribe.						
20	The foregoing Resolution was duly enacted by the Papago Council on the 7th						
	day of July, 1983, at a meeting at which a quorum was present with a vote of 1440.0 for; 0 against; 0 not voting; and0 absent,						
21	pursuant to the authority vested in the Papago Council by Section 2 (a), (d)						
22	and (m) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and						
2 3	approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is						
24	not subject to review by the Secretary of the Interior and is effective as						
	of the date of its enactment by the Papago Council.
