1 WHEREAS, the Papago Council has reviewed the proposed plan and budget for the Sonoran Papago office for the period beginning July 1, 2 1983, through September 30, 1983, and approves of the same; and 3 WHEREAS, the Chukut Kuk District Council did on January 13, 1983, recognize the urgent problems faced by the Sonoran Papagos; and 4 WHEREAS, the Chukut Kuk District Council voted to help the Sonoran Papagos 5 by contributing \$5,000.00 from their District funds to operate 6 an office; and WHEREAS, the Papago Council recognizes the need and urgency of this office to begin operating. 8 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve 9 the proposed budget to operate the Sonoran Papago office beginning 10 July 1, 1983, through September 30, 1983, and does authorize expenditures in accordance herewith. 11 The foregoing Resolution was duly enacted by the Papago Council on the 6th 12||day of July, 1983, at a meeting at which a quorum was present with a vote of 1440.0 for; 0 against; 0 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (f), <u>1440.0</u> for; 0 (1) and (m) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
