

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Moratorium on Sale, Lease or Land Development

RES. NO. 105-83

1 WHEREAS, the San Xavier District Council did enact Resolution No.  
2 6-83-8, requesting a moratorium on all land sales, leases  
3 or land development of all land located within the San Xavier  
4 Reservation, Tribal or allotted until such time as a  
5 comprehensive long term land use plan for the public is  
developed; and

6 WHEREAS, the Papago Council had reviewed the reasons and motivation  
7 behind this request for the moratorium and approves of the  
same.

8 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby  
9 suspend immediately all land sales, leases and development  
10 of all land located within the San Xavier Reservation until  
11 such time as a comprehensive long term land use plan is  
completed.

12 BE IT FURTHER RESOLVED that the suspension shall be in effect for 180  
13 days and may be extended by the San Xavier District Council  
14 for an additional period not to exceed 180 days, if necessary,  
to complete the land use plan.


15 BE IT FURTHER RESOLVED that this moratorium on sales, leases or land  
16 development shall not apply to land located within the San  
17 Xavier Industrial Park, the Papago Free Trade Zone, the San  
18 Xavier Farm Cooperative, to lands set aside for housing and  
19 urban development, to lands already subject to existing lease  
20 agreements, or to lands within the proposed lease area of and  
21 which are a part of land authorized by the District Council  
for use in construction of roads, public utilities and other  
22 public facilities.

23 The foregoing Resolution was duly enacted by the Papago Council on the  
24 7 day of July, 1983 at a meeting at which a quorum was present with a  
25 vote of 1440.0 for; 0 against; 0 not voting; and 0  
26 absent, pursuant to the authority vested in the Papago Council by  
27 Section 2 (c), (h) and (m) and Section 3 (d) of Article V of the  
28 Constitution and by-laws of the Papago Tribe of Arizona as amended,  
ratified by the Papago Tribe on December 12, 1936, and approved by the  
Secretary of the Interior on January 6, 1937, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
effective as of the date of its approval by the Superintendent of the  
Papago Agency and is subject to review by the Secretary of the Interior.


