WHEREAS, the Papago Tribe of Arizona is presently operating the following program under FY 1983 P. L. 93-638 Contract with the Bureau of Indian Affairs;

#### Papago Children's Home

- WHEREAS, such Tribal operation had been successful and beneficial to the Papago Tribe and its people; and
- WHEREAS, the Papago Tribal Council does desire to recontract for provision of these services during FY 1984.
- NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does authorize and request the Bureau of Indian Affairs to contract with the Papago Tribe under P. L. 93-638 regulations and procedures for the provision of services titled:

#### Papago Children's Home

- BE IT FURTHER RESOLVED that the duration of this contract shall be from October 1, 1983 through September 30, 1984.
- BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate programs from which contracts are requested herewith which have not been negotiated and executed by the Bureau of Indian Affairs prior to the start of the funding year.
- BE IT FURTHER RESOLVED that if the contract is not executed by the Bureau of Indian Affairs prior to October 1, 1983, the Papago Tribal Council will request the Arizona Congressional delegation for an oversite hearing of the Phoenix Area Office.
- BE IT FURTHER RESOLVED that the Papago Tribal Council hereby requests to have all contract negotiations conducted at the Tribal Offices in Sells, Arizona.
- BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice-Chairman or Rosita Ruiz, Treasurer, of the Papago Council is hereby authorized to negotiate and execute this contract and any amendments hereto for the duration of the contract.
- The foregoing Resolution was duly enacted by the Papago Council on the 7 day of July, 1983 at a meeting at which a quorum was present with a vote of  $\underline{1440.0}$  for;  $\underline{0}$  against;  $\underline{0}$  not voting; and  $\underline{0}$  absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (d) and (m) of Article V of the Constitution and by-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
