

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Evaluation of Tribal Health Programs Proposal/IHS

RES. NO. 115-83

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following
2 programs under a P. L. 93-638 service contract with the Public
3 Health Indian Health Service:

4 Alcoholism Prevention and Education
5 Community Health Representative Program
6 Coordination of Health Service
7 Papago Psychological Service

8 WHEREAS, such Tribal operations have been successful and beneficial to the
9 Papago Tribe and its people; and

10 WHEREAS, the Papago Tribal Council has selected health as the tribal priority
11 for funding and construction; and

12 WHEREAS, substantial budget cuts have been incurred by the Tribal Health
13 Programs since February of 1982; and

14 WHEREAS, such budget cuts have resulted in program reductions, program
15 eliminations and program retrocessions; and

16 WHEREAS, the Tribal Council has approved the reorganization of Tribal
17 Health Program management; and

18 WHEREAS, the Tribal Council does desire to be informed on the current status
19 of the Tribal Health Programs and does desire that a Tribal Health
20 Program evaluation be conducted.

21 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does
22 authorize and request the Public Health, Indian Health Service to
23 contract with the Papago Tribe under P.L. 93-638 regulations and
24 procedures for the provision of services titled:

25 Evaluation of Tribal Health Programs

26 BE IT FURTHER RESOLVED that the duration of this contract shall be from
27 September 1, 1983, through December 16, 1983, unless extended by
28 mutual agreement of both parties.


29 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate programs
30 for which contracts are requested herewith which have not been
31 negotiated and executed by the Indian Health Service prior to the
32 start of the contract.

BE IT FURTHER RESOLVED that Mr. Josiah Moore, Chairman, or in his absence,
Mr. Francisco Jose, Vice Chairman, or Rosita N. Ruiz, Treasurer,
is hereby authorized to negotiate and execute this contract and
any amendments thereto for the duration of the contract.


The foregoing Resolution was duly enacted by the Papago Council on the 4th
day of August, 1983, at a meeting at which a quorum was present with a vote
of 1219.5 for; 0 against; 220.5 not voting; and 2 absent,
pursuant to the authority vested in the Papago Council by Section 2 (d), (e)
and (f) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is

1 not subject to review by the Secretary of the Interior and is effective as of
2 the date of its enactment by the Papago Council.
