

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Responding to Request/Church of Jesus Christ of Latter Day Saints

RES. NO. 11-83

1 WHEREAS, the Sells Branch of the Church of Jesus Christ of Latter Day
 2 Saints has appealed to the Papago Council the decision of the
 3 Sells District Council not to grant it a lease; and
 4 WHEREAS, the Papago Council has determined that this is a local matter
 5 which should be resolved at the District level.
 6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
 7 refer the request of the Sells Branch of the Church of Jesus
 8 Christ of Latter Day Saints back to the Sells District Council
 9 with the recommendation that the Church review all alternatives,
 10 including site relocation into another District or into the
 11 Agency Reserve, with the Sells and Baboquivari District Councils.

12 The foregoing Resolution was duly enacted by the Papago Council on the 7th
 13 day of January, 1983, at a meeting at which a quorum was present with a vote
 14 of 392.5 for; 501.5 against; 147.0 not voting; and 4 absent,
 15 pursuant to the authority vested in the Papago Council by Section 2 (f) of
 16 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
 17 amended, ratified by the Papago Tribe on December 23, 1936, and approved by
 18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
 19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
 20 review by the Secretary of the Interior and is effective as of the date of
 21 its enactment by the Papago Council.
