RES. NO. 123-83

WHEREAS, the Papago Council did by Resolution No. 122-83, approve the equal distribution of Entitlement #14, \$226,264.00, to each of the 11 Districts in allotments of \$15,063.81; and

WHEREAS, there is a balance of \$60,562.00 proposed for use in administering the Revenue Sharing program; and

WHEREAS, the Papago Council has reviewed the proposed use of the \$60,562.00 and finds it to be in the interests of the Papago Tribe and the Revenue Sharing office and approves the same.

NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve the budgeting of \$60,562.00 for use in administrating the purposes of the Revenue Sharing office.

The foregoing Resolution was duly enacted by the Papago Council on the day of August, 1983, at a meeting at which a quorum was present with a vote of 592.0 for; 460.0 against; 388.0 not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 3 (a) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
