ENROLLMENT - SEPTEMBER

RES. NO. 132-83


26 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
27 named applicants are eligible for enrollment as members of the
28 Papago Tribe under Section 1 (a) or (b) of Article II of the
29 Papago Constitution and By-laws, as amended, and their applica-
30 tions are approved, as herein above indicated.

31 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
32 the Papago Tribe reduce this final determination in writing


1 regarding each of the foregoing applications for enrollment in
2 accordance with Section 1 (C) of Article VIII of the Papago
3 Enrollment Ordinance; give notice of this Council's deter-
4 mination in accordance with Section 2 (a) and (b) of Article
5 VIII of the Papago Enrollment Ordinance; and place the names
6 of each applicant upon the Tribal Membership Roll in accordance
7 with Article IX of the Papago Enrollment Ordinance.

8 The foregoing Resolution was duly enacted by the Papago Council on the 8th
9 day of September, 1983, at a meeting at which a quorum was present with a vote
10 of 1333.0 for; 0 against; 0 not voting; and 3 absent,
11 pursuant to the authority vested in the Papago Council by Article II and
12 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
13 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
14 approved by the Secretary of the Interior on January 6, 1937, pursuant to
15 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
16 not subject to review by the Secretary of the Interior and is effective as
17 of the date of its enactment by the Papago Council.
