

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Approving Agreement for Recovery of
Treasure-Trove at San Xavier

RES. NO. 134-83

1 WHEREAS, W. L. Chapline, Phil Branch and C. E. Springer ("the Operators")
2 believe that they know the whereabouts of treasure-trove concealed
3 on lands within the San Xavier Reservation and have proposed to
4 locate and recover such treasure-trove on behalf of the Papago
Tribe; and

5 WHEREAS, the San Xavier District Council has reviewed their proposal and
6 has agreed that it would be in the best interest of the District
7 and the Tribe that such treasure-trove be recovered under an
8 exclusive employment contract wherein the Operators recover the
treasure-trove at their expense and upon compensation contingent
on actual recovery; and

9 WHEREAS, pursuant to the Escheat Ordinance of the Papago Tribe treasure-
10 trove and abandoned property as therein defined escheat to and
11 rest in the Papago Tribe; and

12 WHEREAS, this Council has reviewed a proposed agreement between the Tribe
13 and the Operators and approves thereof on the following stipula-
tion:


- 14 1. Sub Section 4.2.2 provides that all on-site physical
15 aspects of the operations be under the immediate
16 supervision and control of two tribal managers, one
17 a resident of the San Xavier Reservation appointed
18 by the San Xavier District Council, the other
19 appointed by the Papago Council.
- 20 2. That the compensation provision contained in section
21 5 be renegotiated in order to obtain the highest
22 possible return to the Tribe which shall in no event
23 be less than 60% of recovery.

24 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
25 approve the form of the proposed agreement between the Papago
26 Tribe and W. L. Chapline, Phil Branch and C. E. Springer, as
Operators, that it does hereby authorize and direct the Chairman
and Attorney for the Papago Tribe to renegotiate in accordance
with the stipulations contained herein and that, if they can
reach agreement, the Chairman and Secretary of this Council are
hereby authorized and directed to execute such agreement on
behalf of the Papago Tribe.

27 The foregoing Resolution was duly enacted by the Papago Council on the 8th
28 day of September, 1983, at a meeting at which a quorum was present with a vote
29 of 764.5 for; 429.5 against; 336.0 not voting; and 0 absent,
30 pursuant to the authority vested in the Papago Council by Section 2 (a) and
31 (c) of Article V of the Constitution and By-laws of the Papago Tribe as
amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of
its enactment by the Papago Council.
