Authorizes Josiah Moore, Chairman, Francisco Jose, Jr., Vice Chairman or Rosita Ruiz, Treasurer, of the Papago Council to negotiate and execute all documents, including, but not necessarily limited to, applications, agreements, amendments, and other documents which may be necessary for the completion of this project.

Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
