2 Francisco J.; MACIAS, Angelita (Hernandez); GARCIA, Sam Juan;  
3 CHOYGUHA, Anthony E. III; LOPEZ, Lola (Hernandez); HOOD,  
4 Juanita (Neblina); and ORTEGA, Jose V. have made application for  
5 adoption into Tribal membership pursuant to Section 2 of  
6 Article II of the Constitution of the Papago Tribe; and  
7 WHEREAS, the Enrollment Committee has reviewed their respective applications  
8 has made a final determination that they are 1-1/2 degree or  
9 more of Papago Indian blood, and have made a recommendation to  
10 the Papago Council that their applications be approved, all in

day of October, 1983, at a meeting at which a quorum was present with a  
vote of 1058.5 for; 0 against; 381.5 not voting; and 1 absent,  
pursuant to the authority vested in the Papago Council by Section 2  
of Article II of the Constitution and By-laws of the Papago Tribe of  
Arizona as amended, ratified by the Papago Tribe on December 12, 1936,  
and approved by the Secretary of the Interior on January 6, 1937, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution  
is not subject to review by the Secretary of the Interior and is effective  
as of the date of its enactment by the Papago Council.
