[WHEREAS, Leona Begay Hendricks, a person listed as Navajo Indian on the 1 Base Roll of the Papago Tribe, has applied for membership in the 2 Papago Tribe under Section 1 (a) of Article II of the Constitution 3 of the Papago Tribe, as amended, and a motion was made to accept her into membership; and 4 WHEREAS, no recommendation of the Enrollment Committee to either accept 5 or reject her application was before the Council for consideration 6 prior to action on the motion as is required by the Enrollment Ordinance. 7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Leona Begay 8 Hendricks be admitted into membership by the Papago Council. 9 The foregoing Resolution was duly enacted by the Papago Council on the 14th day of October, 1983, at a meeting at which a quorum was present with a vote of 491.0 for; 896.5 against; 52.5 not voting; and 1 absent. 10 of $\underline{491.0}$ for; $\underline{896.5}$ against; $\underline{52.5}$ not voting; and $\underline{1}$ absent pursuant to the authority vested in the Papago Council by Section 2 (f) of absent, 11 Article V and Section 1 (a) of Article II of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Art of June 18, 1934 (48 Stat. 984).
