## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL ENROLLMENT - OCTOBER

RES. NO. <u>168-83</u>

WHEREAS, the Papago Council has reviewed the recommendations of the Papago Enrollment Committee in accordance with Section 1 of Article VIII of the Papago Enrollment Ordinance, Ordinance No. 05-81, and has made a final determination that the application of the following applicant for membership in the Papago Tribe be approved:

ARTICLE II - MEMBERSHIP SECTION (1a) ALL INDIANS WHOSE NAMES APPEAR ON THE OFFICIAL CENSUS ROLLS

466-CK-83 HENDRICKS, Leona (Begay)

NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant is eligible for enrollment as a member of the Papago Tribe under Section 1 (a) or (b) of Article II of the Papago Constitution and By-laws, as amended, and that the application is approved, as herein above indicated.

BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Papago Tribe reduce this final determination in writing regarding the foregoing application for enrollment in accordance with Section 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give notice of this Council's determination in accordance with Section 4 of Article III of the Papago Tribal Enrollment Ordinance; and place the name of the applicant upon the Tribal membership roll in accordance with Article V of the Papago Tribal Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the  $\frac{14\text{th}}{\text{day}}$  of October, 1983, at a meeting at which a quorum was present with a vote of  $\frac{1440.0}{\text{of}}$  for;  $\frac{0}{\text{against}}$  against;  $\frac{0}{\text{not}}$  voting; and  $\frac{2}{\text{absent}}$ , pursuant to the authority vested in the Papago Council by Article II and Article V, Section 1 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
