

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Adopt San Lucy Land Assignment

RES. NO. 172-83

1 WHEREAS, the Act of August 20, 1964 (78 Stat. 559), authorized the relocation
2 and resettlement of the village of Sil Murk through the purchase of
3 a 20 acre tract of land, including construction of community
4 facilities and other improvements; and
5 WHEREAS, title to the resettlement site and related facilities and improve-
6 ments is held by the United States of America in trust for the
7 Papago Tribe of Arizona; and
8 WHEREAS, the resettlement site has never been formally added to the San Lucy
9 District by the Papago Council; and
10 WHEREAS, the Papago Council is empowered by Article IV, Section 1, of the
11 Papago Constitution to change the territories of the various
12 districts; and
13 WHEREAS, the San Lucy District Council pursuant to the authority granted to
14 it under Section 2 of Article IV and Section 3 of Article VIII of
15 the Papago Constitution wishes to exercise its powers by making
16 assignments of lots to individuals.

17 NOW, THEREFORE, BE IT RESOLVED that the Papago Council pursuant to its
18 authority under Article IV, Section 1, of the Papago Constitution
19 does hereby formally add to the San Lucy District, the resettlement
20 site of 20 acres of land described as the E $\frac{1}{2}$, NE $\frac{1}{4}$, SE $\frac{1}{2}$ of
21 Section 25, Township 5 South, Range 5 West, Gila and Salt River
22 Meridian, Arizona; and 20 acres of land described as E $\frac{1}{2}$, SE $\frac{1}{2}$, NE $\frac{1}{2}$
23 of Section 25 Township 5 South, Range 5 West, Gila and Salt River
24 Meridian, Arizona.

25 BE IT FURTHER RESOLVED that the San Lucy District Council proceed and confirm
26 the assignments of lots and improvements pursuant to Article VIII,
27 Section 3 of the Papago Constitution.

28 The foregoing Resolution was duly enacted by the Papago Council on the 14th
29 day of October, 1981, at a meeting at which a quorum was present with a vote
30 of 1440.0 for; 0 against; 0 not voting; and 1 absent,
31 pursuant to the authority vested in the Papago Council by Section 2 (h) and
32 (m) and Section 3 (h) and (k) of Article V of the Constitution and By-laws of
the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on
December 12, 1936, and approved by the Secretary of the Interior on January 6,
1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
Resolution is effective as of the date of its approval by the Superintendent
of the Papago Agency and is subject to review by the Secretary of the Interior.


