

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Request to Recontract P.L. 93-638/Indian Health Service

RES. NO. 176-83

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following  
2 program under a continuation of FY '83 P.L. 93-638 service  
3 contract with the Public Health, Indian Health Service:

Management of Health Services

4 WHEREAS, such Tribal operations have been successful and beneficial to the  
5 Papago Tribe and its people; and

6 WHEREAS, 25 CFR Sec. 371.20 requires that all proposals to recontract under  
7 P.L. 93-638 be submitted to the Tribal Council for approval at  
8 least 120 days prior to the contract termination; and

9 WHEREAS, the Papago Tribal Council does desire to recontract for provision  
10 of these services during FY 1984.

11 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does  
12 authorize and request the Public Health Indian Health Service to  
13 contract with the Papago Tribe under P.L. 93-638 regulations and  
14 procedures for the provision of services titled:

Management of Health Services

15 BE IT FURTHER RESOLVED that the duration of this contract shall be from  
16 January 1, 1984, through December 31, 1984, unless extended by  
17 mutual agreement of both parties.

18 BE IT FURTHER RESOLVED that in the event that this contract does not become  
19 effective on January 1, 1984, continuation of this program will be  
20 based on an extension of the existing 1983 contract until such  
21 time that the 1984 contract becomes effective.

22 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate a  
23 program for which a contract is requested herewith and that has  
24 not been negotiated and executed by the Indian Health Service  
25 prior to the start of the funding year.

26 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, or in his absence,  
27 Francisco Jose, Vice Chairman, or Rosita N. Ruiz, Treasurer, is  
28 hereby authorized to negotiate and execute this contract and any  
29 amendments thereto for the duration of the contract.

30 The foregoing Resolution was duly enacted by the Papago Council on the 14th  
31 day of October, 1983, at a meeting at which a quorum was present with a vote  
32 of 1440.0 for; 0 against; 0 not voting; and 1 absent,  
pursuant to the authority vested in the Papago Council by Section 2 (a) and  
(d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1973, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
review by the Secretary of the Interior and is effective as of the date of  
its enactment by the Papago Council.
