RESOLUTION OF THE PAPAGO TRIBAL COUNCIL Revoking Resolution No. 12-83

RES. NO. 17-83

WHEREAS, upon petition of the Sells Branch of the Church of Jesus 1 2 Christ of Latter Day Saints, the Papago Council did, by 3 Resolution No. 12-83, request the Bureau of Indian Affairs to make available to the Papago Tribe three acres of land 4 5 for purpose of leasing such land to the Church; and WHEREAS, the Council has heard testimony from the Sells District 6 7 Council in support of its original refusal to grant the 8 Church a lease. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, on 9 10

reconsideration, it does hereby revoke Resolution No. 12-83.

The foregoing Resolution was duly enacted by the Papago Council on the 11th day of February, 1983, at a meeting at which a quorum was present with a vote of 684.0 for; 292.0 against; 172.0 not voting; and 1 absendant to the authority vested in the Papago Council by Section 2 (f) of absent, 13 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
