1 WHEREAS, a position as Associate Judge of the Papago Tribal Courts is presently vacant; and 2 WHEREAS, Section 2 of Chapter I of the Law and Order Code of the Papago 3 Tribe, as amended by Ordinance No. 05-83, provides that all Judges of the Papago Tribal Courts shall be appointed by the 4 Papago Council; and ō WHEREAS, the Law and Order Committee has recommended the appointment of 6 LARRY GARCIA for the position of Associate Judge of the Papago 7 Tribal Courts; and WHEREAS, LARRY GARCIA meets all of the qualifications for such position. 8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 9 appoint LARRY GARCIA as Associate Judge of the Papago Tribal 10 Courts for a term of two years from date of appointment. The foregoing Resolution was duly enacted by the Papago Council on the 3rd 11 day of November, 1983, at a meeting at which a quorum was present with a vote 0 of 1440.0 for; 0 _ not voting; and against; Ω absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
