RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (San Xavier Land Transfer)

RES. NO. 187-83

WHEREAS, There is within the exterior boundaries of the San Xavier Papago 1 Reservation a parcel of Government, Bureau of Indian Affairs, 2 land identified inpart as Rancho De Martinez; and 3 WHEREAS, The Bureau of Indian Affairs had an agency headquarters situated on this Real Estate during the early part of this century; and 4 WHEREAS, There are no existing government buildings standing on said 5 property, which is currently being used as San Xavier Co-Op 6 Farm headquarters and inpart under cultivation for the Co-Op; and 7 WHEREAS, the San Xavier District Council enacted Resolution No. 9-83-2 on the 13th day of September, 1983, wherein it requested this 8 Council to enact a Resolution petitioning the Bureau of Indian 9 Affairs to transfer title of government lands located within the 10 exterior boundaries of the San Xavier Papago Reservation, a copy of said resolution is attached hereto and made a part thereof; and 11 WHEREAS, It would be in the best interest of the Papago Tribe and the San 12 Xavier District if said title to government land located within the San Xavier Papago Reservation be transferred to the Papago 13 Tribe of Arizona as apart and portion of the San Xavier District. 14 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does 15 hereby petition the Bureau of Indian Affairs, the Department 16 of the Interior and the United States Government to do whatever is necessary to transfer title to all government lands located 17 within the exterior boundaries of the San Xavier Papago Reservation 18 and no longer used by the government to the Papago Tribe of Arizona such lands identified in part as the Rancho De Martinez containing 19 80 acres more or less, further identified as follows: Lands 20 lying inpart in the Southeast Quarter of Section 22; Northwest 21 Quarter of Section 27, R.13E., T.15S, G.&S.R., B.&M., Pima County, 22 Arizona. BE IT FURTHER RESOLVED that the Chairman, Vice Chairman, Secretary and **2**3 Treasurer do whatever is necessary to carry out the purposes of 24 this Resolution, including but not limited to the execution of all 25 necessary transfer documents. 26

The foregoing Resolution was duly enacted by the Papago Council on the $\frac{4\text{th}}{4\text{day}}$ of November, 1983, at a meeting at which a quorum was present with a vote of $\frac{1365.0}{1365.0}$ for; $\frac{0}{1365.0}$ against; $\frac{75.0}{1365.0}$ not voting; and $\frac{1}{1365.0}$ absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (m) of Article V and Section 1 of Article VIII of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
